In the Cloud Shell, create an App Service plan in the resource group with the az appservice plan create command.

Step 3: az webapp create

In the Cloud Shell, create a web app in the myAppServicePlan App Service plan with the az webapp create command. Don't forget to replace with a unique app name, and <docker-ID> with your Docker ID.
